RECITALS	
<p>The Purchaser is paying the Breeder a deposit to hold one Border Collie Dog (the "Dog"), this acts as a promise to Purchase a Dog from the Breeder. The Breeder will "hold" Dog and refuse sale to any other party. Payment of a Deposit signifies agreement to the 'Terms and Conditions' herein.</p>	

TERMS AND CONDITIONS:

1. **Contract** - As a condition to the sale of the Dog, the Purchaser, by submitting this Deposit, has reviewed, accepts, and agrees to sign and be bound by the Terms and Conditions of an additional Contract governing the sale of the Dog.
2. **Payment** - Once the Deposit has been paid, the Breeder will refrain from selling the Dog to another party, unless otherwise specified herein. The balance of the Purchase Price is due as specified ABOVE. Payment of the balance may be made by cash, e-transfer, or bank to bank wire transfer.

3. **Forfeit Deposit** - Purchaser will forfeit the Deposit and any rights to the Dog if: (I) Purchaser fails to complete the purchase of the Dog for any reason, or (II) Purchaser fail to pay the balance of the Purchase Price within the time limit specified. Purchaser refuses to sign the Breeders Contract. In either event, Breeder shall be free to sell the Dog to another party.
4. **Refund/Roving Deposit** - The Deposit and purchase price may be refunded at anytime at the full discretion of the Breeder prior to Purchaser taking PHYSICAL possession of Dog, with no explanation, nor reason, and Breeder can refuse to complete the sale to Purchaser. In the event that the Dog is not available due to sickness, death, or any other circumstance (i.e. Breeder determines, at Breeders sole discretion, that no Dog in the litter fits what the Purchaser requests), the Deposit will, at Breeders option, be either: (A) refunded, or (B) transferred to the another litter of puppies.
5. **Puppy Designation** - Purchaser understands that Breeder will choose a quality puppy for the Purchaser according to Purchasers request for either a show quality (which will be CO-OWNER by Breeder) or pet quality puppy. Purchaser is aware that IF Breeder has a Dog that matches the Purchaser, determined so at the sole discretion of the Breeder, and Purchaser refuses such Dog, NO refund of the Deposit will be owed to the Purchaser as the Deposit will then cover the monies lost by the Breeder. Dogs are not placed based on colour, but on temperament, structure, and quality.
6. **Receipt** - Breeder will issue a receipt of the deposit to Purchaser through e-mail.
